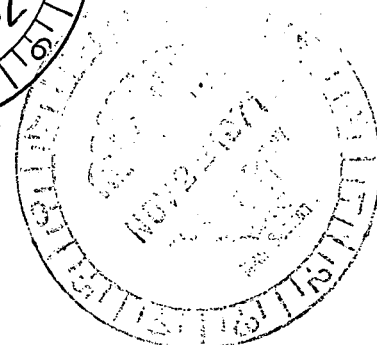
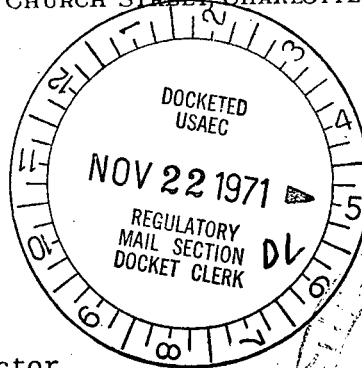

Dear Dr. Morris:

This letter supplements my letters of October 18, 1971 and October 29, 1971 which submitted the following documents in support of Duke Power Company's Application for Licenses for the Oconee Nuclear Station which is under construction pursuant to provisional construction permits CPPR-33, -34, and -35 issued by the Commission on November 6, 1967:

1. Supplement to Environmental Quality Features of Keowee-Toxaway Project (Supplemental Environmental Report), October, 1971.
2. Request for the Issuance of an Operating License Authorizing Limited Power Operations, Unit No. 1, Docket No. 50-269.
3. Statement by the Applicant Why the Construction Permits Should Not Be Suspended, Units 2 and 3, Docket Nos. 50-270, 50-287.

The following table provides additional information verbally requested by the Division of Reactor Licensing staff in regard to costs of the station construction through October, 1971; costs of job shutdown for the next six months for both Oconee and its associated transmission lines; and predicted expenditures for the next six months for both Oconee construction and transmission line construction.

1. Expenditures at Oconee Nuclear Station through October 31, 1971.	\$328,916,428
2. Predicted expenditures for the next six months at Oconee Nuclear Station including fuel costs and interest.	\$ 77,087,000

3. Estimated cost of job shutdown for Ocone Units 2 and 3 including demobilization, personnel lay-off, caretaker operation, remobilization with additional two month delay, additional escalation, interest, and hypothetical purchased power since adequate power may not be available. \$ 48,193,000
4. Predicted expenditures for the next six months for transmission lines including construction, land acquisition, and land clearing. \$ 14,441,000
5. Estimated additional cost of job with six month shutdown for transmission lines with no attempt to make up lost time. \$ 6,768,000
6. Estimated additional cost of six month job shutdown for transmission lines with corresponding make up of time. \$ 13,736,000
