

Correspondence from your office to Duke Power Company indicates that a copy of the correspondence is being sent to Roy B. Snapp, Esq. at his office on K Street.


Mr. Snapp is no longer associated with Duke Power Company and therefore, I wish to delete his name from the list of people to receive correspondence concerning Duke Power Company.
