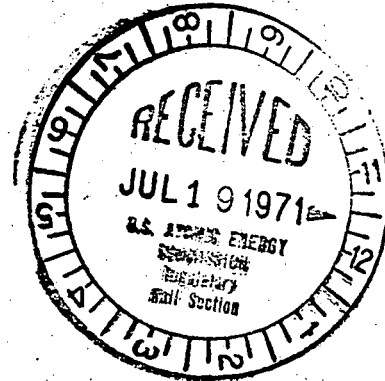

Mr. Snapp is no longer associated with Duke Power Company and therefore, I wish to delete his name from the list of people to receive correspondence concerning Duke Power Company.

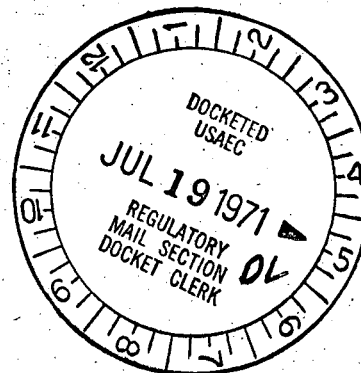
