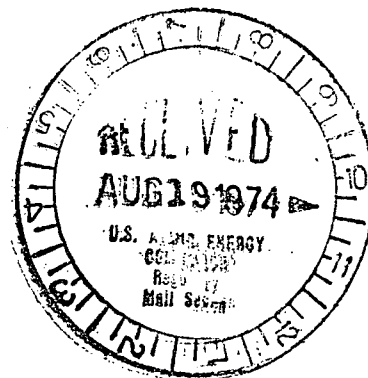

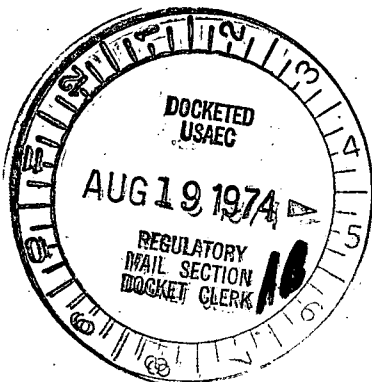
Dear Mr. Goller:

As requested in your letter of July 22, 1974, please be advised that the additional information relating to spent fuel handling at Oconee Nuclear Station will be submitted on September 30, 1974. This additional information will be furnished as an amendment to the Oconee FSAR. Since spent fuel shipments from Oconee will not commence until 1975, fuel cask handling will not be necessary during this period of evaluation.
