Dear Mr. Rausch:

The NRC Office of Investigations (OI), Region I (RI), initiated an investigation on April 25, 2014, to determine whether a Concerned Individual (CI), who had been employed as an instructional technologist in the training department at Susquehanna Nuclear, LLC's (Susquehanna's) Susquehanna Steam Electric Station (SSES), was subjected to discrimination for raising safety concerns. Based upon documentary and testimonial evidence developed during the OI investigation, there was insufficient evidence developed for the NRC to substantiate that the CI was subjected to discrimination for raising safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records, a copy of which is enclosed for your information.
