SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON JANUARY 28, 2016

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on January 28, 2016. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP), Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS), Units 2 and 3.

The meeting notice including the agenda can be found in the Agencywide Documents Access and Management System (ADAMS) under Accession No. ML15356A256. The meeting notice is also posted on the NRC public website. The meeting talking points may be found under ADAMS Accession No. ML16027A014. The enclosure contains the attendance list for the meeting. Talking Point 6 resulted in SCE&G stating that it planned to address this item by providing additional information in a supplement to the original LAR but that no audit was necessary. The staff understood the licensees' proposed plan to address these talking points.

There was an opportunity for the public to provide comments and ask questions. No comments or questions of the staff were offered by the attendees. The meeting ended at 10:11am.
