**Public Meeting on NRC Draft Digital Instrumentation and Control**

On January 20, 2016, the staff held a Category 2 public meeting with the Nuclear Energy Institute (NEI) and other industry stakeholders to discuss the NRC draft Digital Instrumentation and Control (DI&C) Regulatory Improvement Action Plan and NEI's "Digital I&C Roadmap." The staff and NEI discussed potential approaches for coordinating work on respective plans. The meeting focused on key NRC and industry initiatives in updating 50.59 guidance, improving licensing guidance, addressing software common cause failure, and Electric Power Research Institute's guide in digital design.
