Public Meeting to Discuss Proposed Revisions to Draft Subsequent License Renewal Documents

On January 21, 2016, the staff held a Category 3 meeting and webinar to discuss the proposed revisions to the draft Generic Aging Lessons Learned for Subsequent License Renewal (GALL-SLR) Report and Standard Review Plan for the Review of Subsequent License Renewal Applications for Nuclear Power Plants (SRP-SLR), as well as the bases for the proposed changes. These draft documents describe acceptable methods for managing aging for reactor operation from 60 to 80 years, as well as techniques for the staff to use in evaluating applications for subsequent license renewal. Additional public meetings are scheduled for February 19 and February 23; participation details will be posted on the NRC's Website at <http://meetings.nrc.gov/pmns/mtg>. The NRC published a notice in the *Federal Register* (80 FR 79957) requesting public comment by February 29, 2016, on the draft Subsequent License Renewal documents.

Staff Issues Renewed Operating License for Braidwood Station, Units 1 and 2

On January 27, 2016, the staff issued the renewed operating licenses for Braidwood Station, Units 1 and 2, authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration dates are October 17, 2046, for Unit 1 and December 18, 2047, for Unit 2. The staff completed the review, as documented in the Safety Evaluation Report, NUREG-2190, published in December 2015, and Supplement 55 to the Generic Environmental Impact Statement for License Renewal of Nuclear Plants, NUREG-1437, published in November 2015. The issuance of the Braidwood Station, Units 1 and 2, renewed licenses brings the total number of renewals to 83 reactor units
