SUBJECT: WITHHOLDING PROPRIETARY INFORMATION FROM PUBLIC
DISCLOSURE - SUBMITTAL OF TOPICAL REPORT 0815-16497, "SAFETY
CLASSIFICATION OF PASSIVE NUCLEAR POWER PLANT ELECTRICAL
SYSTEMS," REVISION 0 (PROJECT NO. 0769)

Dear Mr. Bergman:

In an October 29, 2015 letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15306A126), Mr. Steve Mirsky, Licensing Manager, NuScale Power, LLC, requested that the proprietary version of the following topical report (TR) be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- NuScale Power, LLC – Enclosure 2, Topical Report 0815-16497, "Safety Classification of Passive Nuclear Power Plant Electrical Systems," Revision 0

A nonproprietary copy of the TR has been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS at the following accession number:

- NuScale Power, LLC – Enclosure 1, **TR-0815-16497-NP, Revision 0, "Safety Classification of Passive Nuclear Power Plant Electrical Systems."** (ADAM Accession No. ML15306A065)

The affidavit, in the letter dated October 29, 2015, stated that the submitted TR should be considered exempt from mandatory public disclosure due to the proprietary nature of the information contained in the report.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
