The purpose of this modification is to:
 1. reduce the overall ceiling of the base year by \$2,275.01 to account for the discount related to the full text requirement which took place between March and May 2015 and
 2. exercise option period 1, which extends the period of performance through February 28, 2017 and increases the ceiling by \$230,098.26. The obligated amount is also increased by \$227,823.25.
