
License Condition 10aa states:

*UUSA-P2P-ISSP, Encrypted Point to Point Data Exchange Information System Security Plan, Revision 1, dated April 14, 2015, subject to revision to integrity setting for the Point to Point Data Exchange from Secure Hash Algorithm (SHA) - 1 to, at least, SHA-256 setting as required by the Committee on National Security Systems (CNSS) Policy Number 15, "National Information Assurance Policy on the Use of Public Standards for the Secure Sharing of Information Among National Security Systems," dated October 1, 2012. This revision must be made no later than October 1, 2015, with a letter of confirmation submitted to the NRC upon completion.*

The setting changes required by LC 10aa were completed and provided to the NRC and the Department of Energy (DOE) for review on September 30, 2015 via electronic correspondence using the UUSA NRC Document Exchange eRoom. Subsequent to the eRoom upload, the changes were provided with Reference 2, which included the NRC on its distribution. This correspondence is the letter of confirmation specified in LC 10aa.
