Discussion: Mr. Simpson sent me an email on a January 21, 2016, with the email attached saying that it was "For Official Use Only" and disseminated only on a "Need to Know" basis. Also it said the email was privileged and confidential. I talked to Mr. Simpson and he said that it was not confidential and can be publically released.

With the email was an attachment for Appendix A. Appendix A contained pictures of the facility he desired to be released along with the attached building and parking lot area. The pictures were labeled as "FOR OFFICAL GOVERNMENT USE ONLY, Unauthorized reproduction or distribution prohibited, DO NOT REMOVE THIS NOTICE, and Properly destroy documents when no longer required." I asked if his agency classified this and if they had procedures to do so. I also told him that I did not need the pictures for this licensing action and he could request for them to be returned or destroyed. He asked for them to be destroyed.

Action Required: Destroy Appendix A and place the rest in ADAMS.

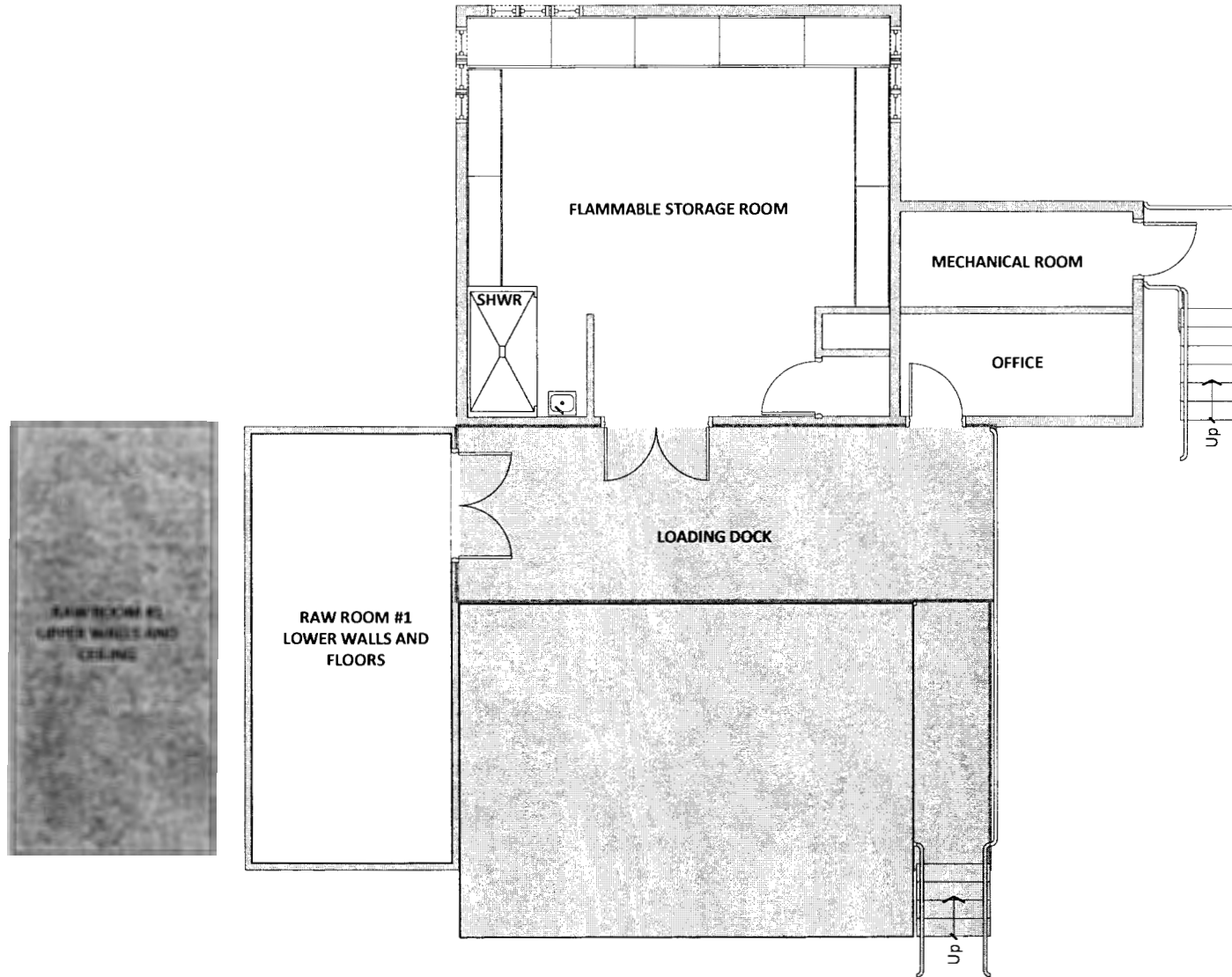

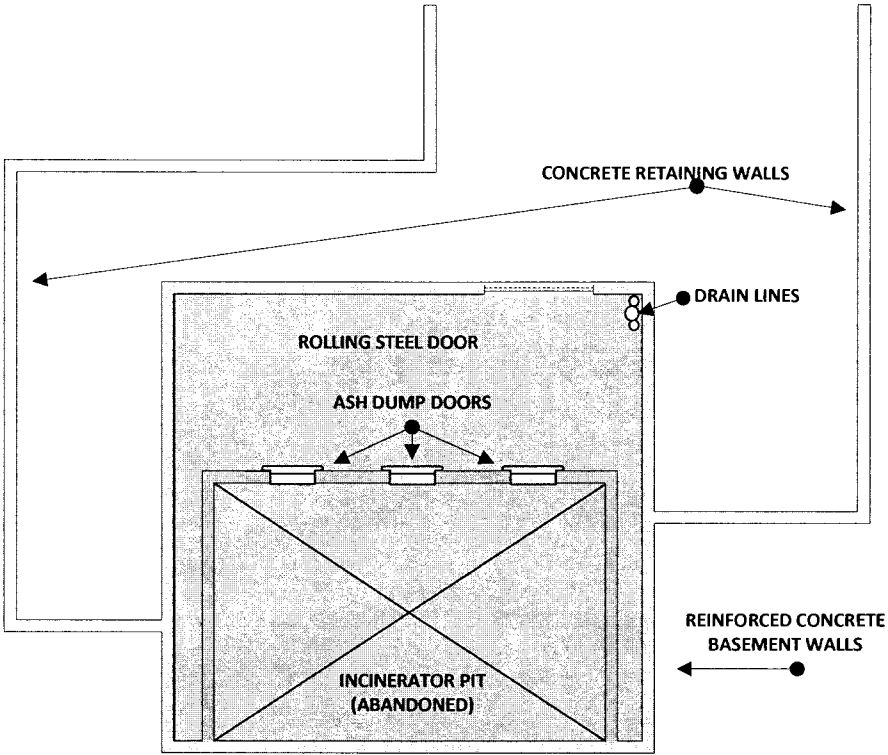
