Dear Mr. Padilla:

Enclosed is Amendment No. 06 to your NRC Material License No. 21-35013-01 in accordance with your request. Changes to your license appear in **bold** font, especially License Condition Nos. 12, 15, 17 and 20.

Condition No. 12 changes the RSO to you. Condition No. 15 was incomplete so we completed it at this time. Condition No. 17 was revised to remove the regulatory reference to 10 CFR 30.34(i), which carries the force of law, in and of itself, as a regulation and need not be called out on a license. We added ADAMS accession numbers to all documents listed in Condition No. 20.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


