On January 14, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at the Catawba Nuclear Station, Units 1 and 2, and discussed the results of this inspection with members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report (IR).

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations, and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

No findings were identified during this inspection.
