SUBJECT: SUMMARY OF A PUBLIC MEETING ON FEBRUARY 26, 2015, WITH MEMBERS OF THE AP1000 DESIGN CENTER TO DISCUSS AP1000 DESIGN MATTERS FOR THE LEVY NUCLEAR PLANT UNITS 1 AND 2 COMBINED LICENSE APPLICATION: ESTIMATED DOSE TO MAIN CONTROL ROOM OPERATORS, HEATUP, AND HYDROGEN VENT LOCATION INSPECTION, TEST, ANALYSIS, AND ACCEPTANCE CRITERIA

The U.S. Nuclear Regulatory Commission (NRC) staff held a public meeting on February 26, 2015, at 9:00 a.m. with members of the AP1000 design center.¹ The purpose of this meeting was for the Levy Nuclear Plant Units 1 and 2 applicant to present details of the methodology and proprietary calculations related to three AP1000 design matters addressed in request for additional information (RAI) Letter Nos. 121 and 122: (1) the estimated dose to main control room operators, (2) heatup of the main control room, and (3) the hydrogen vent location Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC) No. 3 in the AP1000 Design Control Document, Revision 19, Tier 1 Table 2.3.9-3.² Duke Energy Florida (DEF) presented an overview of the planned approaches during the public portion of the meeting. Westinghouse Electric Company (Westinghouse) presented proprietary details of the approaches during the closed (nonpublic) portion of the meeting. Also during the closed portion of the meeting, Westinghouse presented an update of their status on the containment condensate return design change. Slide presentations of the information presented are publicly available in ADAMS.³ The list of attendees is enclosed.
