Discussion: 12:30 I spoke with Mr. Allison and confirmed that the licensee had filed bankruptcy. I asked him to refer me to an individual who was responsible for bankruptcy notifications since the NRC had not received a notice of the licensee filing bankruptcy at this time. 13:10 Mr. Allison called to inform me that the filings were on-line and could be viewed as public documents. I stated that was why we were aware of the bankruptcies but that 10 CFR 30.34(h) requires licensees to inform the NRC immediately in writing providing the date of filing and the court in which the bankruptcy was filed once a licensee files for bankruptcy. Mr. Allison stated that he would speak to a representative from corporate and inform him of the regulation. 14:10 Mr. Allison called and stated that he would like to e-mail the letter to me. I requested that the letter be faxed since I had difficulties forwarding e-mails to the proper individual for processing. Mr. Allison agreed to fax the letter.
