Subject: Error on NRC license / Corrected Copy

Discussion: I called Mr. DiPuppo in response to questions from his office during a recent inspection. The questions were regarding jurisdictional status of work performed by the USACE and contract companies hired by USACE. I informed Mr. DiPuppo that the USACE does not need to file reciprocity for work at USACE projects using licensed material within the United States. I also informed him that contract companies using licensed materials at locations not specifically authorized by license would need to contact the regulatory agency for that location and file for reciprocity. We discussed the need to determine jurisdiction of the location for which any work is to be performed using licensed material. I informed Mr. DiPuppo that the USACE license contained an error regarding authorized use locations and jurisdictional status, and that the USACE license would be corrected by my office to include the proper language in Condition 10 regarding authorized storage and use locations. I informed him that it was NRC's error and that a corrected copy of the license would be issued as soon as possible.
