On January 28, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Waterford Steam Electric Station, Unit 3. On January 28, 2016, the NRC inspectors discussed the results of this inspection with Mr. R. Gilmore, General Manager, and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
