Hi Ty,

I apologize for one last request, but I turned in my final for review and an inconsistency was found. NUREG-1757 requests that an “originally signed duplicate” of the self-guarantee

agreement be submitted with the self-guarantee letter. After reviewing the language myself, it appears that the purpose was to ensure that the original agreement was still in full force and effect as it could be cancelled by the licensee by supplying notice to the NRC. Resubmitting it with the package seems to be a confirmation that it is still in full force and effect without changes. IFIB is reviewing several of these and wants to remain consistent.

Pages 6 – 9 of the attached document is the original self-insurance guarantee from October 5, 2009 that should be included with the self-guarantee letter for 2015.

Once I receive the ADAMS Accession Numbers for the 2015 Treasurer's Report and the originally signed duplicate of the self-guarantee agreement, the review will be presented to the BC for signature.
