Issuance of Draft Supplemental Environmental Impact Statement for LaSalle County Station, Units 1 and 2

On February 8, 2016, staff issued for public comment the draft supplemental environmental impact statement (SEIS) on the proposed renewal of the operating licenses for LaSalle County Station, Units 1 and 2. The report contains the preliminary finding that there are no environmental impacts that would preclude license renewal for an additional 20 years. As part of its environmental review, the NRC will hold a public meeting on March 22, 2016, near the plant to discuss the preliminary findings in the draft SEIS and to solicit public comments on the document. The public comment period ends on April 4, 2016.
