SUBJECT: NRC CONSENT TO DIRECT LICENSE TRANSFER AND AMENDMENT NO. 04

Dear Ms. Updike:

By letter dated November 9, 2015, Portage Heart Care, P.C. submitted to the U.S. Nuclear Regulatory Commission (NRC) a Request for Consent to direct License Transfer of NRC Materials License No. 13-32478-01. Based on the information provided by Kais Yehyaw, M.D., Portage Heart Care, P.C., and Luis F. Molina, Vice President, Finance, and Chief Financial Officer, Community Care Network, we understand that as a result of a proposed purchase of assets by Community Care Network from Portage Heart Care, P.C., control of Portage Heart Care, P.C. would be directly transferred to Community Care Network. We further understand that this transfer will not result in any change to the licensed materials, persons using the licensed material, location of use of licensed material, or persons responsible for the licensee's radiation safety program. Based on information provided by the same individuals in the 2015 letter, we understand that, on January 1, 2016, all of Portage Heart Care, P.C.'s assets and operations were directly transferred to Community Care Network. We have updated the license accordingly.

Enclosed is Amendment No. 04 to your NRC Material License No. 13-32478-01 in accordance with letter dated January 6, 2016, confirming that the transaction has been completed as described in the November 9, 2015 letter. Please note that we have also added the NRC's Agencywide Documents Access and Management System (ADAMS) accession number to the September 23, 2013 renewal application identified in Item 14.A. and to the January 14, 2014 letter identified in Item 14.B. Changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Enclosure 2 to this letter contains sensitive security-related information.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the proposed transfer.
