NOTIFICATION OF THE U.S. NUCLEAR REGULATORY COMMISSION PUBLIC MEETING

**Purpose:** To provide notification of a Commission Meeting to discuss strategic programmatic overview of the fuel facilities and the nuclear materials users business lines.

**Background:** To provide a briefing to the Commission on the strategic vision over the next 2 or 5 years for these two programs, the U.S. Nuclear Regulatory Commission (NRC) is hosting a public meeting February 25, 2016, at NRC Headquarters. The topics for the nuclear materials users business line portion of the meeting will include the Materials Inspection Program, Part 37 Implementation and Assessment, information on the NRC's Agreement State program and Integrated Materials Performance Evaluation Program, and the status of the NRC's draft Tribal Policy Statement.

**Discussion:** The meeting will take place on Thursday, February 25, 2016, from 9:00 AM to 12:00 PM.
