Dear Dr. McClure:

Enclosed is Amendment No. 60 to your NRC Material License No. 21-12829-01 in accordance with your request. We have reviewed the close-out surveys for Room 105 at Greenville, Michigan location. Based on the provided information, we determined that all licensable radioactive material has been removed and residual radioactive material attributable to licensed activities in Room 105 does not exceed NRC requirements. Therefore, we have authorized the release of Room 105 for unrestricted use. Please note that the changes made to your license are printed in **bold** font.

Additionally, we updated the tie-down documents in the License Condition 14. The letter dated June 24, 2014 and the application dated June 25, 2014 listed in License Condition 14 in Amendment No. 59 referred to the same document which was the renewal application; therefore, we removed one of the two entries.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
