SUBJECT: NUSCALE POWER, LLC - REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE IN THE PROGRESS TOWARD RESUMING NUSCALE POWER'S PRE-APPLICATION PROJECT (PROJECT NO. 0769)

Dear Mr. Bergman:

In a May 16, 2011, letter (Agencywide Documents Access and Management System (ADAMS) Accession No. ML111380204), Mr. Edward G. Wallace, Senior Vice President, Regulatory Affairs, at NuScale Power, LLC, requested that the proprietary letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- Progress Toward Resuming NuScale Power's Pre-Application Project, NP-LO-0511-195-P (ADAMS Accession No. ML111380204).

In the May 16, 2011, letter the affidavit (ADAMS Accession No. ML111380208) stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information presented.

We have reviewed your request in accordance with the requirements of 10 CFR 2.390, and on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the slides. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
