Dear Mr. Robinson:

On February 4, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Oconee Nuclear Station, Units 1, 2, and 3. The inspection covered one or more of the key attributes of the Security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on February 4, 2016, with you and members of the Oconee security staff.

The inspection examined activities conducted under your license as they related to security and compliance with the Commission's rules and regulations, and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel. Portions of this inspection were completed at your Corporate Support Facilities during the week of November 30 – December 4, 2015.

The NRC inspectors did not identify any findings or violations of more than minor significance.
