SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

Dear Mr. Weeks:

This refers to your amendment request dated January 22, 2016 (Agencywide Documents Access and Management System (ADAMS) No. ML16053A030), for U.S. Nuclear Regulatory Commission (NRC) exempt-distribution license number 29-20609-02E for the purpose of changing the name on your license from "Philips Lighting Company-A Division of Philips Electronics North America Corporation" to "Philips Lighting North America Corporation."

We currently do not have sufficient information to continue our review of your request. Although the information you provided indicates that only the name of your company has been changed, as opposed to a change of control, the license reviewer has a responsibility to determine the exact circumstances that led to the change. Please note that Title 10 of the *Code of Federal Regulations* (10 CFR), Part 30, Section 30.34(b), states: "No license issued or granted pursuant to the regulations in this part and parts 31 through 36, and 39 nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall, after securing full information, find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing."

In addition, NUREG-1556, Volume 15, "Consolidated Guidance About Materials Licenses: Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses," contains guidance concerning changes of control. Specific information about changes of control is provided in Chapter 5 and Appendices C, D, and F. Please review this information to determine whether your request does or does not involve a change of control, and then respond accordingly.

Also, please provide a copy of your possession and use license from the State of Maryland, and/or a copy of correspondence to indicate that the State has approved of your continued possession and use of byproduct material.

We will continue our review upon receipt of this information. If we do not receive your reply within 30 calendar days from the date of this letter, we will consider your application as having been abandoned by you. This action would be without prejudice to the resubmission of another application with the required information.

Please be aware that you may request that certain portions of your submittal to NRC be withheld from public disclosure as proprietary information. To do this, you must execute an affidavit as specified in 10 CFR 2.390. You must list all portions that you wish to be held proprietary, along with your reasoning as to why that is appropriate. While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be in the public domain, and therefore may be viewed by any member of the public who requests to see them.
