**Incorporation by Reference of American Society of Mechanical Engineers (ASME) Codes and Code Cases: Proposed Rule; Public Meeting; Part 2 of Title 10 of the Code of Federal Regulations (Regulation Identifier Number 3150-AI97; NRC-2011-0088)**

On February 22, 2016, the NRC published a document in the *Federal Register* ([81 FR 8666](#)) announcing plans to hold a public meeting to discuss proposed amendments to its regulations to incorporate by reference seven recent editions and addenda to the ASME codes for nuclear power plants, an ASME standard for quality assurance, and four ASME code cases. The purpose of the meeting is to discuss public comments on the proposed rule, in order to enhance the NRC's understanding of the comments. The public meeting will be held on March 2, 2016, from 1:00 p.m. to 4:30 p.m. (EST). Participation in the public meeting will be via teleconference and Webinar only. **Subsequent License Renewal Public Meeting**

On February 19, 2016, staff and management met with the representatives of the Nuclear Energy Institute and other stakeholders to discuss draft Subsequent License Renewal (SLR) documents, including the draft Generic Aging Lessons Learned for Subsequent License Renewal (GALL-SLR) and Standard Review Plant for SLR (SRP-SLR), related to the structural and electrical aging management programs (AMPs). The staff also discussed the format of the technical bases document. Additionally, as follow up to the previous public meeting on January 21, the participants discussed aging management of pressurized water reactor vessel internals.
