Subject: RAI, Training, Purpose, Materials

Discussion: I talked to Mr. Hinton as some items on the amendment request needed clarification. I stated that 6.A. through 6.D. is not authorized for the purpose of training and asked if he wanted it added. He said he did. I asked him what EODMU FIVE stood for, he said he would find out and get back to me. I asked that he redo the training requirements as it did not state for some materials when they needed the specialized training, nor did it specify if additional training was needed for personnel working with unsealed materials. Additionally, it needed to address how the training was accessed. I discussed how we would combine sealed sources of the same isotope for the same use and thus a couple of his additions would need to be combined. The activity amount for Cf-252 would stay the same as the additional amount was minimal. The same for the Ba-133 amount. As for Th-228, I discussed that adding that to the license would cause an additional fee be assessed to the license. He said not to add the source.

Action Required: Mr. Hinton would get me information about what EODMU FIVE means and redo the training requirements.
