Dear Mr. Bergman:

In a March 3, 2015, letter, submittal of presentation materials entitled "Fuel and Control Rod Assembly Design," Revision 0, (PM-0215-11298) for use during a meeting on March 19, 2015 (NRC Project No. 0769)," (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15069A386), Mr. Steven Mirsky, Manager, Licensing, at NuScale Power, LLC, requested that the proprietary version of the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- "Fuel and Control Rod Assembly Design," PM-0215-11298-P, Revision 0 (ADAMS Accession No. ML15069A390)

A nonproprietary copy has been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room at (ADAMS Accession No. ML15069A388).

In the March 3, 2015, letter, the affidavit (ADAMS Accession No. ML15069A389) stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information presented and discussed.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
