Dear Mr. Goodyear:

This letter refers to your February 16, 2016, correspondence, in response to our January 22, 2016, letter. The Notice of Violation requested that your response address the following:

1. The reason for the violation,
2. The corrective steps you have taken and the results achieved,
3. The corrective steps that will be taken to avoid further violations, and
4. The date that full compliance will be achieved.

Thank you for providing the information describing the corrective action that has been completed as of February 16, 2016. Your completed corrective action adequately addressed Items A. and D. of the Notice of Violation dated January 22, 2016. However, we noted that your response was incomplete. You have stated the corrective action that was taken to remedy the violations in the short term, however you have not provided corrective steps taken to avoid further violations for items B., C. and E. of the Notice of Violation. Please describe the corrective action you have taken or plan to prevent recurrence of these violations.

Please respond within 30 days of the date of this letter and assure that your response to this letter adequately addresses the Notice of Violation dated January 22, 2016. Where good cause is shown, consideration will be given to extending the response time.
