On March 3, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection of the Independent Spent Fuel Storage Installation at your Virgil C. Summer Nuclear Station. The enclosed inspection report (IR) documents the inspection results that were discussed on March 3, 2016, with you and members of the Virgil C. Summer staff.

No findings were identified during this inspection.
