As we discussed, during review of the NRC Safety Evaluation for the MPS3 Alternative Request IR-3-27 for Implementation of Extended Reactor Vessel Third Inservice Inspection Interval dated Feb. 16, 2016, two minor editorial items were noted. On the top of page 4, item 1, 4<sup>th</sup> sentence, the acronym RTmaxx is defined as "Radiographic Testing – maximum." It should be "Reference Temperature – maximum." On page 6, second paragraph, the 3<sup>rd</sup> sentence states "....TWCF<sub>95-TOTAL</sub> for MPS3 was  $1.44 \times 10^{-3}$ ,...." but the correct value for TWCF<sub>95-TOTAL</sub> is  $1.44 \times 10^{-13}$ .
