The Order required compliance with additional security measures (ASMs) for physical protection, access authorization and fingerprinting at ISFSIs. On February 17, 2014, SCE&G submitted its response to the Order for the Virgil C. Summer ISFSI.

On December 16, 2015, SCE&G informed the NRC that it had achieved full compliance with its implementation of the ASM requirements contained in EA-13-228 and was prepared to demonstrate compliance with the ISFSI Security Order. Additionally, on March 3, 2016, SCE&G submitted its physical security plan (PSP) to the NRC. The NRC performed an on-site physical security inspection, dated March 8, 2016, to ensure compliance with the ASMs.

Based on our review, the NRC staff finds that SCE&G's responses to the Order are acceptable. The NRC has determined that SCE&G has effectively implemented the ASMs through an on-site inspection (IR No. 07201038/2016401) of the Virgil C. Summer Nuclear Station ISFSI.
