On February 12, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Donald C. Cook Nuclear Power Plant, Units 1 and 2. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The inspection results were discussed on February 12, 2016, with you and other members of your staff. The inspector documented the results of this inspection in the inspection report that was provided to you with our letter dated March 7, 2016 (ML16067A381).

The original report contained minor errors in Section S06 concerning the documentation and completion of inspection samples, which are corrected in the inspection report enclosed with this letter.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

No findings were identified during this inspection.
