### **RAI (b) Response**

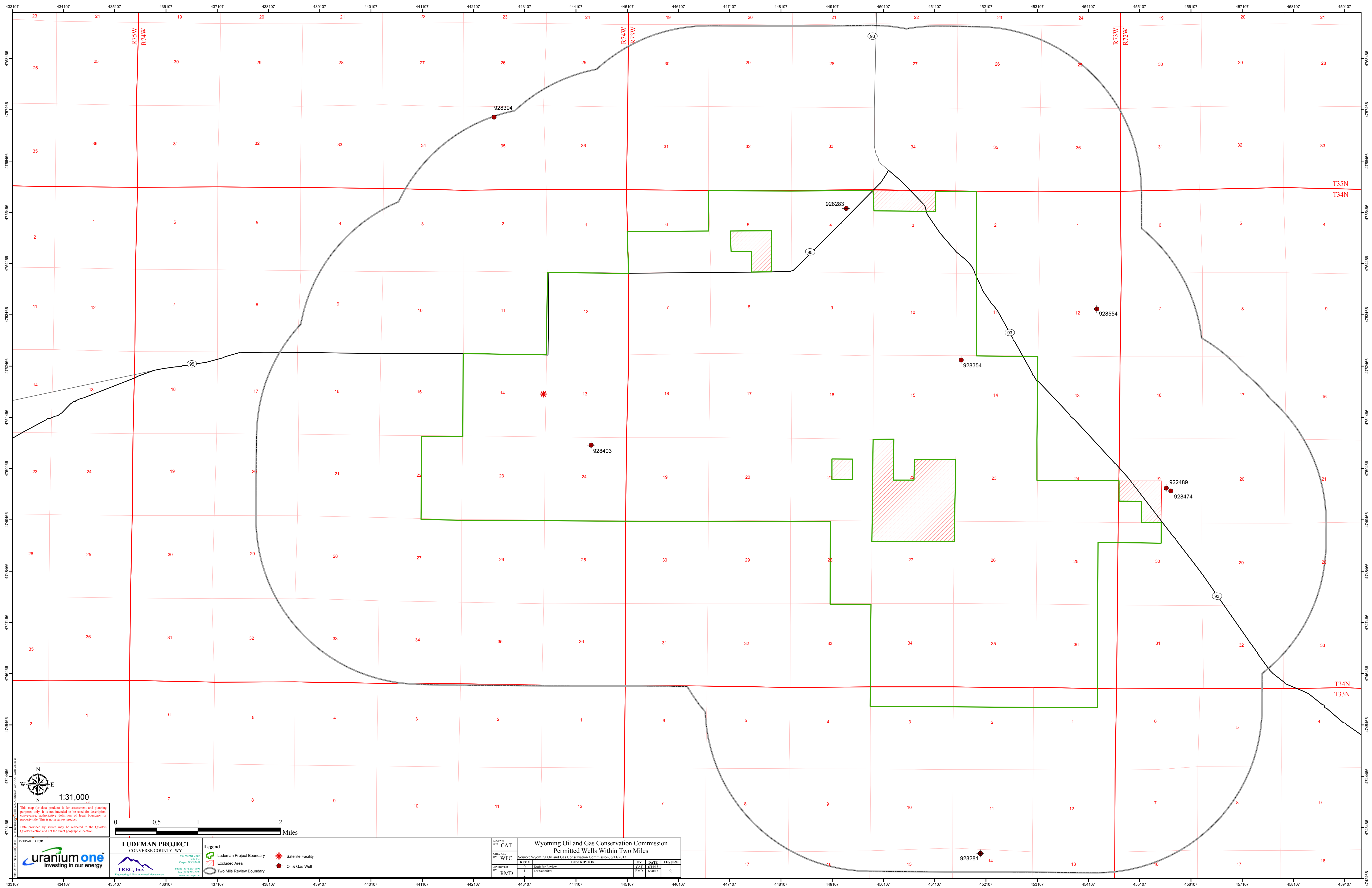
