Pursuant to 10 CFR 72.70, and in accordance with 10 CFR 72.4, Pacific Gas and Electric Company (PG&E) hereby submits the Diablo Canyon Independent Spent Fuel Storage Installation (ISFSI) Updated Final Safety Analysis Report (UFSAR), Revision 6. Revision 6 incorporates changes to the Diablo Canyon ISFSI UFSAR from March 1, 2014, through January 27, 2016. Under the provisions of 10 CFR 72.48(c), there were no changes made that did not require prior NRC approval. Revision 6 of the Diablo Canyon ISFSI UFSAR incorporates changes associated with License Amendment 3.
