On March 9, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Brunswick Steam Electric Plant. The NRC inspectors discussed the results of this inspection with you and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report (IR).

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations, and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

No findings were identified during this inspection.
