


The purpose of this modification is to terminate for convenience NRC contract number NRC-HQ-12-C-29-0108, to execute a no cost settlement agreement between the Axiom corporation and the Government, and to de-obligate \$215,927.49 of excess funding. As a result of this termination for convenience, the ceiling and obligated amount are reduced from \$560,006.40 to \$344,078.91.

(a) This settlement agreement modifies the contract to reflect a no-cost settlement agreement with respect to the Notice of Termination dated February 4, 2016.
