Dear Mr. Layton:

The purpose of this letter is to submit to the U.S. Nuclear Regulatory Commission (NRC) the enclosed cyber security plan SP-HQ-0002, *American Centrifuge HQ Classified Administrative Thin Client System Security Control Security Plan, Revision 1*. The cyber security plan has been revised to reflect the relocation of the Centrus Energy Corp. (Centrus) Headquarters restricted area from its current location at 6903 Rockledge Drive, Bethesda, Maryland, to the adjacent building, 6901 Rockledge Drive. Operation of the thin client system in the new location will be conducted with the same procedures and equipment that we are currently using.

The changes to SP-HQ-0002, Revision 0, approved by NRC on April 24, 2015, are

- Page 8, MA-1: Location changed to 6901 Rockledge Drive and building management updated
- Page 15, PE-2: Added "Accounts are disabled after 60 consecutive days without logging in."
- Page 17, PE-6: Identified IDS monitoring service provider at new location.


