10 CFR 35.70 states, in part, that in addition to the surveys required by Part 20, a licensee shall survey with a survey instrument at the end of the day of use.

Contrary to the above, February 16, 2016, the licensee failed to survey all areas where unsealed byproduct material requiring a written directive was prepared for use or administered with a radiation detection survey instrument at the end of each day of use. Specifically, the licensee conducted the surveys at the beginning of the day prior to use of the material.

This is a Severity Level IV Violation (Enforcement policy example: Section 6.7.d)

The licensee implemented corrective actions that included: retraining all personnel in the expectations for daily surveys at the end of each day of use in accordance with NRC regulations.
