Pursuant to 10 CFR 72.212, "Conditions of general license issued under §72.210," paragraph (b)(4), Dominion Nuclear Connecticut, Inc. (DNC) hereby provides the Nuclear Regulatory Commission (NRC) notification regarding the updated registration of spent fuel storage casks approved under NRC Certificate of Compliance (CoC) No. 1004.
