We reviewed your letter dated November 25, 2015, transmitting Revision 13 of your Physical Protection Plan. We find the changes to be acceptable. Specifically, we find that Nuclear Fuel Services was authorized to make the changes without prior U.S. Nuclear Regulatory Commission (NRC) approval pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Section 70.32.

Your submittal was assigned Cost Accounting Control Number: L33399. The number is considered **CLOSED**.

However, during the review of your changes, we identified issues where compliance with some security requirements is unclear. A request for additional information in the next revision of the plan is enclosed. We request that you inform us within 30 days of your plan to address these issues. We are available to meet if you would like to discuss the resolution of our concerns.
