Byron has no post exam comments for the 2016 Byron Initial License Examination administered March 14 to March 25, 2016.

The master examination and answer keys were hand delivered to Michael Bielby on March 7, 2016. The facility has made no changes to the exam since then.

Per our discussion with Michael Bielby, we request the NRC withhold public disclosure of the exam in ADAMS for 2 years so we can have the exam available for internal use.



Additionally, we request the procedure for RO Admin JPM RA-d, "Activate Everbridge Notification" be withheld from public disclosure because it contains proprietary information. The proprietary information contained within the JPM has been redacted, so that JPM itself may be published. The procedure that we request to be withheld is EP-AA-112-100-F-06, "ERO NOTIFICATION OR AUGMENTATION."

The exam exit will be conducted by Michael Bielby, NRC Chief Examiner, via a telephone conference when the exam grading is completed.
