The U.S. Nuclear Regulatory Commission (NRC) staff has completed its review of IBA Molecular North America, Inc. Surety Bond No. K09211378 dated November 30, 2015, and effective July 31, 2015, for NRC License Number 45-25221-05. In addition, the staff has completed its review of the Standby Trust Agreement Amendment dated February 29, 2016, for NRC License Number 45-25221-05 in accordance with NUREG-1757, Volume 3, Revision 1, "Financial Assurance, Recordkeeping, and Timeliness." Based on this review, the NRC staff has determined that the financial assurance mechanism and supporting documentation conforms to NRC guidance.

As a result of the approval of the new Surety Bond (Surety Bond No. K09211378), we have cancelled and are returning the previously approved Surety Bond No. 1096128 dated January 21, 2014 with a Bond Rider effective January 21, 2014 and signed July 8, 2014. We are also cancelling and returning Standby Trust Agreement dated August 25, 2010, and Amendment dated August 20, 2014.
