SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON FEBRUARY 25, 2016

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on February 25, 2016. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3.

Summary of Meeting:

On February 25, 2016, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4, and SCE&G's VCSNS Units 2 and 3. Specifically, the meeting discussed SCE&G's draft license amendment request (LAR 14-02), "Wall 11 Design Related Changes, Supplement 2" (WEC LAR-30).

In the open portion of the meeting, Enclosure 3 of LAR 14-02, Supplement 2 was discussed, and SCE&G explained that the purpose of the LAR is to protect Wall 11 by crediting Wall 11.2 and the first bay of the Turbine Building. SCE&G described their voluntary responses to the staff's questions from the public meeting held on January 28, 2016 (ADAMS Accession No. ML16027A014). The staff understood SCE&G's responses and provided comments for SCE&G to consider before formally submitting the LAR. First, the staff noted that the LAR language is unclear in some places and that the submittal should specifically clarify whether design changes or detailing changes are being requested (structural codes specifically distinguishes between the two). Additionally, the staff noted that additional information on the barriers, such as specific steel and anchor materials, location, size, etc., are necessary to evaluate if the requirements of the barriers are met, specifically the ductility requirements. SCE&G stated that they understood the staff's concerns and that they would address the comments in the Supplement 2 submittal.

At the end of the open portion of the meeting, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before ending the open portion of the meeting.

In closed portion of meeting, the staff and the licensees discussed the proprietary details of the LAR, including security related details.
