Dear Mr. Lawyer,

On December 21, 2015, you informed Nordion (Canada) Inc. ("Nordion") that the NRC had consented to the indirect transfer of control (*see* Reference 1) associated with the corporate reorganization described in Nordion's application of November 19 (*see* Reference 2). Reference 1 required that Nordion "notify the NRC in writing" if the corporate reorganization did not occur within 30 days, to avoid the NRC's consent from possibly becoming "null and void." To avoid that possible outcome, Nordion notified Region I on January 20, 2016, that the transactions described in Reference 2 were expected to occur on or before March 20, 2016 (*see* Reference 3).

The transactions described in Reference 2 are now expected to occur on or before June 6, 2016. Nordion hereby notifies Region I of the new expected transaction date to avoid the possible

outcome of the NRC's consent becoming "null and void." There are no changes to the transactions described in Reference 2 other than the closing date.
