They provided a copy of a permit issued by Roger Williams Medical Center listing Dr. Stainken as an AU for SIRspheres. I contacted the RSO at Roger Williams to confirm that Dr. Stainken had completed the 3 proctored cases with the Sirtex representative. According to J.
