(Centrus) to discuss Centrus' proposed Security Plan for the Protection of Classified Matter at its relocated headquarters in Bethesda, MD. During the call, the NRC and DOE staffs discussed their comments with Centrus' staff on the proposed security plan. By letter dated March 31, 2016, Centrus provided its revision to the proposed security plan addressing the NRC
