Dear Mr. Toelle:

I am responding to your letter AC 16-0003, dated February 24, 2016 (Agencywide Documents Access and Management Systems (ADAMS) Accession Number ML16092A114), requesting the U.S. Nuclear Regulatory Commission's (NRC's) review and approval of the proposed Security Plan for the Protection of Classified Matter at Centrus Energy Corp.'s (Centrus') relocated Headquarters in Bethesda, Maryland (the Plan). The Plan had been revised to reflect the new location, room layout, construction, intrusion detection system and monitoring service provider for the new Centrus Headquarters facility located at 6901 Rockledge Drive, Bethesda, Maryland.

Following our initial review of your request, on March 29, 2016, the NRC staff, in coordination with subject matter experts from the U.S. Department of Energy's (DOE's) Nuclear Energy Oak Ridge Site Office, held a conference call with you to discuss the Plan, provide comments, and clarify some of the information (see call summary under ADAMS Accession Number ML16097A211). By letter dated March 31, 2016 (AC 16-0006, ADAMS Accession Number ML16096A322), you provided a revised Plan addressing the NRC and DOE staff's comments.

The NRC staff has completed its review of the proposed Plan. Based on its review of the information provided in your February 24, 2016, and March 31, 2016, submittals, the Security Plan for the Protection of Classified Matter at Centrus' Headquarters has been approved.

This action completes the efforts under Cost Activity Code number L34358.
