**CATEGORY:** This is a Category 1 meeting. The public is invited to observe this meeting and will have one or more opportunities to communicate with the NRC after the business portion, but before the meeting is adjourned.

**PURPOSE:** The purpose of this pre-decisional enforcement conference is to discuss four apparent violations identified by the NRC: (1) failure to control the radiation dose to a worker within NRC regulatory limits; (2) failure to have adequate procedures in place that assured a safety evaluation was completed for a proposed use of radioactive material and approved by the radiation safety committee prior to its use, (3) failure to obtain prior NRC approval for activities that had not been documented, reviewed, and approved by the company's radiation safety committee; and (4) failure to stop work as required by procedure when a worker's electronic dosimeter alarmed. The apparent violations are discussed in Inspection Report 030-35486/2015-001, dated March 18, 2016 (ADAMS ML16028A493).
